

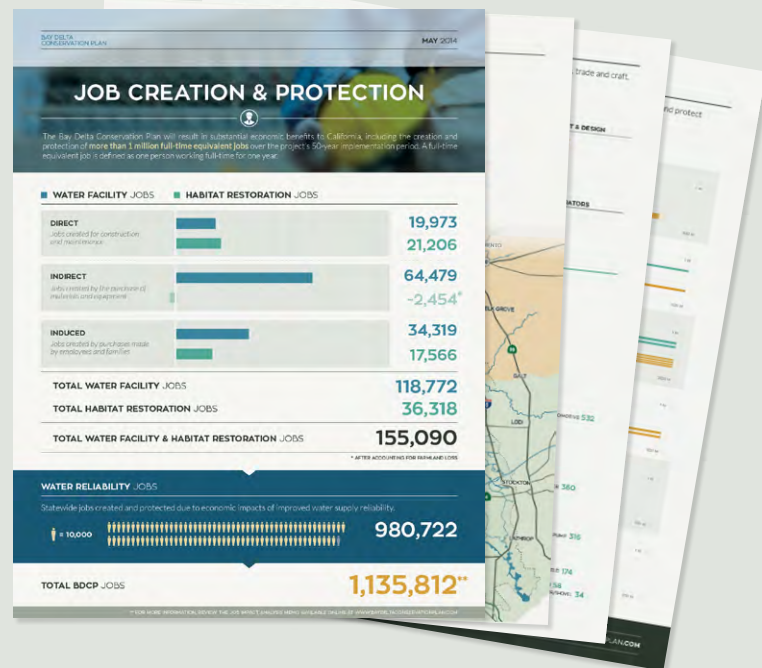


HOW MANY JOBS WILL THE BDCP CREATE?

The BDCP is estimated to result in the creation and protection of more than one million full-time equivalent jobs over the project's 50-year implementation period. (A full-time equivalent job is defined as one person working full-time for one year.) Construction and operation of the proposed water facilities and habitat restoration projects would create an estimated 155,090 jobs in the Sacramento-San Joaquin Delta (Delta) region. In addition, reliable water supplies gained through BDCP implementation will protect and save an estimated 980,722 statewide jobs. ABOUT BDCP

The BDCP proposes to environmentally retrofit and modernize California's primary water delivery system - the Sacramento-San Joaquin River Delta - and restore approximately 150,000 acres of habitat for fish and wildlife. The BDCP is one part of California's overall water portfolio. It aims to protect California's unique Delta ecosystem and secure water supplies for 25 million homes and businesses, and a vast part of the California economy.

REVIEW NEW INFORMATIONAL EPISODES AND MATERIALS

Informational episodes have been created to help the public navigate the draft BDCP and Environmental Impact Report/ Environmental Impact Statement (EIR/EIS). These episodes are video presentations narrated by technical staff, and are designed to help the public find information and learn more about the proposed project. Draft BDCP episodes include topics such as Conservation Measures, Implementation, and Cost and Funding. REMINDER: PUBLIC COMMENT PERIOD EXTENSION

The Draft BDCP, Draft BDCP Implementing Agreement, and Draft EIR/EIS are available for an extended review period. The public review and comment period is effective through July 29, 2014. Comments on the Draft BDCP, associated Draft EIR/EIS, and Draft IA must be received electronically or postmarked on or before July 29, 2014.
